

Rules and Administration - Subcommittee on the Senate Budget

Meeting Minutes – October 19, 2005, 10:00a.m.

Senator Metzen called the meeting to order at 10:24a.m.

Senator Metzen made some opening remarks and highlighted the issues the subcommittee would be considering at this meeting.

Senator Belanger asked a question regarding the percentage increase employees would be receiving.

Patrick Flahaven, Secretary of the Senate, answered Senator Belanger's question.

Several committee members discussed how the dollars should be distributed among high and low income workers.

Senator Pogemiller suggested that we consider a 3 percent base increase with another one half percent based on merit.

JoAnne Zoff Sellner, Director of Senate Counsel, Research and Fiscal Analysis, testified that the structure for pay increases being discussed is consistent with prior practices in the Senate.

Senator Rest asked what the cost of the increase, as proposed, would be.

Patrick Flahaven answered that the cost would about \$1.35 million for the biennium.

The committee discussed who would be considered a qualifying employee for the pay increase this year, and whether the funds were available to pay for the increased salaries.

The committee discussed possible changes to other budget items that would result from salary increases, as suggested by Patrick Flahaven.

The committee discussed a suggestion by Senator Day to adjust usual practice and consider recent hires for the salary increase.

Motion:

Senator Pogemiller moved

1. That the budget proposed by the Secretary of the Senate be adopted.
2. That each employee of the Senate on the date this recommendation is adopted by the Committee on Rules and Administration who has been continuously employed by the Senate since March 31, 2005, and whose performance evaluation is at least "Meritorious:"
 - a. receive a salary increase, retroactive to July 1, 2005, equal to three percent of base salary; and
 - b. be eligible to participate in a salary increase pool of one-half percent of base salaries in each supervisory unit, the amount for each employee to be determined by the employee's supervisor.
3. That each employee of the Senate on July 1, 2006, who has been continuously employed by the Senate since March 31, 2006, and whose performance evaluation is at least "Meritorious:"
 - a. receive a salary increase equal to three percent of base salary; and
 - b. be eligible to participate in a salary increase pool of one-half percent of base salaries in each supervisory unit, the amount for each employee to be determined by the employee's supervisor.

Motion prevailed

Senator Metzen adjourned the meeting at 10:58 a.m.



1. That the budget proposed by the Secretary of the Senate and attached to this report be adopted.
2. That each employee of the Senate on the date this recommendation is adopted by the Committee on Rules and Administration who has been continuously employed by the Senate as a regular employee since March 31, 2005, and whose performance evaluation is at least "Meritorious:"
