Sir:

I am returning herewith House File No. 910 without my approval.

I cannot see my way clear to give approval to this measure allowing Hibbing to extend hours for on-sale liquor places from midnight to 1:00 a.m. on week days and from 1:00 a.m. to 2:00

a.m. on Saturdays. I recognize that there is some justification for the claim that a municipality such as Hibbing should be entitled to have the later closing hours permitted in cities of the first and second class. I do not think, however, that we are going to help the situation by passing another act setting up a special privilege for a specific city as this bill does.

Should this bill be approved, Hibbing would have an hour later closing time than liquor places in other nearby communities on the Iron Range, which, I am sure, would add to the difficulties of regulation. Hibbing's population is equivalent to that of a third class city, and under this act it would acquire a privilege which no other third class city possesses. I think we ought to try to reduce rather than extend differences in regulation. The time is coming when we must endeavor to work out changes that will make our liquor laws more nearly uniform in application. Adjustment of closing hours by all means should be done by general law rather than specific acts.
