Mr. Long, F. D., offered the following resolution and moved its adoption:

*Whereas*, Almighty God in His infinite wisdom, has called a former Member of the Minnesota House of Representatives, Honorable Edward R. Hinds, who served as a member of the House during the Sessions of 1903, 1905, 1909, 1915, 1917, 1919, 1921, representing the 63rd District, Hubbard County, and

*Whereas*, In his death the State has lost a faithful servant, and those who knew him a sincere and earnest friend, who gave freely of his time and means to the general public welfare, serving constantly whenever and wherever entrusted with Public Affairs, a man worthy of confidence and a trusted official, known as a kindly neighbor and devoted husband and father, living the Golden Rule, "Do unto others as you would have them do unto you." Edward R. Hinds was born in Pennsylvania, 1854, moving from there with his parents when a boy to Benton, Maine, where he received his education in the common schools of that town. When 24 years of age he came to Hubbard County,

Minnesota, being among the first settlers to locate on the then known Shell Prairies, which was at that time 40 miles distant from the railroad, and there began the developing of a farm, which was still owned by him at the time of his death and was one of the best in the County. He served with honor to himself and Community, County and State the Office of Postmaster, Member of Town Board, School Board Trustee, County Auditor, County Commissioner and Representative in State Legislature 7 terms, retiring in 1922 to become Superintendent of Itasca State Park, which position he held with credit to the time of his calling to the Better Life, May 3rd, 1924, and

*Whereas*, he has given steadfast service to his County and State.

*Therefore, Be It Resolved*, That the House of Representatives hereby officially declare its sense of loss in his death; express its deep appreciation of his many sturdy and virtuous qualities; and that it extend to his bereaved family its sympathy; and that this resolution, as adopted, be sent to his family in token of our action, and as a mark of our esteem and affection for our devoted Friend and Brother; and

*Be It Further Resolved*, That the Chief Clerk be and is hereby authorized to have an engrossed copy of this resolution sent to the family of the deceased.

Which was adopted unanimously by a rising vote.

Messrs. Sweitzer and MacLean introduced the following resolution:

*Whereas*, since the passage of Chapter 278, General Laws 1921, there has been pending before the Railroad and Warehouse Commission proceedings to determine the value of the street railway properties of the Minneapolis Street Railway Company and the St. Paul City Railway Company, and the taking of testimony in said proceedings has been completed and the matter taken under advisement by the Railroad and Warehouse Commission; and large sums of money have been spent in connection with said proceedings, all of which sums are eventually charged up against the car users, and

*Whereas*, there are numerous suggestions being made and bills introduced proposing amendments to said Chapter 278, General Laws 1921, and some bills proposing its repeal, and

*Whereas*, the Legislature could better determine what amendments if any should be made to said law after a decision has been made by the Railroad and Warehouse Commission, and if any legislation is to be had to further protect the rights of the car users such legislation must be introduced within a short time;

*Now, Therefore, Be It Resolved*, by the House of Representatives of the State of Minnesota, that the Railroad and Warehouse Commission be requested to file its decision at the earliest practicable moment consistent with the proper consideration of the testimony, thereby enabling the Legislature to have more time to consider such amendments to said law as may be proposed.

Mr. Stockwell gave notice of debate, so the Resolution went over for one day.
