When did Minnesota start offering voter registration in the polling place on Election Day?

In 1974, the same year Minnesota began requiring all eligible voters to register to vote. Prior to 1974, registration was not a statewide requirement.

Who was the secretary of state when same-day registration was adopted and first used?

Arlen Erdahl, Republican secretary of state, who served 1971–1975.

How many Minnesotans use same-day registration in a typical presidential election year?

Typically, more than one-half million voters. Most recently in 2012, nearly 528,000 voters used same-day registration. The highest number recorded was 581,904 on Election Day in 2004.

What percentage of registered Minnesota voters has used same-day registration one or more times?

Sixty-one percent of registered voters have used same-day registration.
