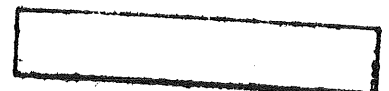

STATEMENT OF NEED AND REASONABLENESS

3700.0600 Licenses in Service Occupational Area

The statutory authority for State Board of Technical Colleges to promulgate these rules as contained Minnesota Statute Section 136 C.04 Subd. 9 which states:

Licensure. The state board may adopt rules according to the provisions of Chapter 14, for the licensure of teaching, support, and supervisory personnel, in post-secondary and adult vocational education. When necessary for continuous programs approved by the board and when the board approves appropriate temporary standards do not exist the board may adopt appropriate temporary standards without regard to Chapter 14 and may issue temporary licenses through teaching and support personnel. A temporary license is valid up to one year and is not renewable, but a person holding a temporary license may, upon its expiration, be issued a license in accordance with standards adopted under Chapter 14. The state board may establish a processing fee for the issuance, renewal, or extension of the license.

Background Information

The technical colleges continue the process of revising existing licensure rules. Initially new rules were placed in 3700. We are in the process of re-editing and numbering all technical college licensure rules to be placed so that all will be in Chapter 3700. 3709 Licenses in the service occupational area are the only rules within that chapter therefore this process is a renumbering of those rules.

3700.0600 Licenses in Service Occupational Area

Subpart 1. Listed Here. These are the same requirements as listed for each rule in 3709. There are no changes in these requirements.

Subpart 2. Recent Occupational Experience. This experience is the same as contained in each individual rule in 3709. There are no changes in this experience.

Subpart 3. Does Not Apply. Removes the applicability of the 3515 chart. This chart is replaced by the revised rules.

Finally, Revisor's Instruction pertains to the renumbering of 3709 rules to 3700. There is no change in the content of this part.

Repealer. Repeals current 3709 rules now covered by renumbered 3700. These processes will be implemented using current policies and will have no fiscal impact

8 Subpart 1. **Listed here.** An applicant for a license to
9 teach postsecondary vocational courses and programs in the
10 service occupational area must meet the requirements in this
11 part. These requirements are in addition to the requirements
12 listed in part 3700.0100 and for a particular license.

13 Subp. 2. **Recent occupational experience.** An applicant for
14 a license to teach in the service occupational area must have
15 2,000 hours of occupational experience within the five years
16 just before applying for that license.

17 Subp. 3. **Does not apply.** Part 3515.9920 does not apply to
18 parts 3700.0610 to 3700.0640.

20 REVISOR'S INSTRUCTION. The revisor shall renumber part
21 3709.0160 as part 3700.0610, part 3709.0170 as part 3700.0620,
22 part 3709.0180 as part 3700.0630, and part 3709.0190 as part
23 3700.0640. The revisor shall renumber part 3709.0350 as part
24 3700.1290 and delete the word "project" from the phrase "project
25 discover" wherever it appears in that part.

26 REPEALER. Minnesota Rules, part 3709.0100, is repealed.
