No. 209, an Act to incorporate the Town of Mount Vernon, for the reason, that no provisions has been made in the Bill for the future election of Town Officers, so that, in effect, the persons named therein to fill the offices of President, Secretary and Trustees are appointed without limit as to time.

S. F. No. 127, a Bill for an Act to provide for the salaries of the Judges of the Supreme and District Courts of the State, was read a first time.

Bill No. 277, for an Act to authorize the Trustees of School District No. 1, in Steele County, to raise money for certain purposes.
