## ***Campaign Financial Status of State Level Candidates***

This document provides a summary of the campaign financial status of candidates whose name will appear on the 2006 general election ballot. The information is gathered from the pre-general Report of Receipts and Expenditures, which candidates file with Campaign Finance and Public Disclosure Board. The pre-general report discloses the candidate's committee status as of October 23, 2006. The summary information is presented in district order by office.

The summary includes total contributions received; total expenditures made, and ending cash balance for each year of the election cycle for the office sought. Detailed information on the names of contributors and the expenditures made by candidates committees are available on the Report of Receipts and Expenditures filed with the Board.
