Tax Amounts by Decile for Calendar Years 2000 and 2005

Introduction

Some readers of the tax incidence study have expressed interest in knowing more detail about the distribution of the various taxes by decile than is given in the text of the report. For their benefit, the following tables contain the complete distribution of every tax analyzed in the incidence study.

The table for each tax shows the amount imposed directly on Minnesota households and the amount of business tax shifted to Minnesota households. The amounts are allocated by both population deciles and income deciles. Also shown are the tax amounts for the top 5% and top 1% of households for each type of decile. Tables are given for 2000 historical data and projected 2005 data.

The 2005 projections are based on the forecast published in February 2003 by the Minnesota Department of Finance.
