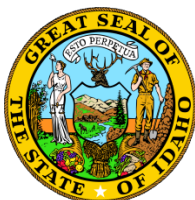

## SEATING OF THE COMPACT COMMISSION

The Interstate Medical Licensure Compact Commission was seated for the first time on October 27, 2015 in Chicago, Illinois. The first meeting lasted two days and adjourned on October 28, 2015. The agenda for the meeting was developed by a working group of representatives from 11 states within the Compact, with assistance from the Federation of State Medical Boards and the Council of State Governments. Once seated, the Commission elected the following officers:
