## **Reporting requirements**

Minnesota Statutes 16B.307, subdivision 2, states that the commissioner of an agency that has received an appropriation for asset preservation (AP) shall submit:

- A list of the projects in each agency funded from Asset Preservation appropriations during the preceding calendar year; and
- A list of priority projects for which an AP appropriation will be sought.

## **Historic Asset Preservation Requests and Appropriations**

The Department of Administration (Admin) maintains a database of over 5,500 state-owned buildings as required by Minnesota Statutes 16A.633). The Enterprise Real Property Program (ERPP) was created by the legislature with the intent that the program assist state agencies to consistently inventory and rate the condition of all state-owned property. While the creation of an enterprise property database enhanced the ability of agencies to evaluate and prioritize asset preservation needs, the ability to fully leverage that data and ERPP to ensure best practices in state property asset management is greatly limited by the limited staff capacity, which currently amounts to 1.0 FTE.

The uniform facility condition assessments completed by state agencies, under the oversight of the ERPP, identifies a backlog of over \$1.2 billion in deferred maintenance needs in state buildings. That amount does not include the deferred maintenance and asset preservation needs at Minnesota State Colleges and Universities (MnSCU) and the University of Minnesota (UMN). Further, the ERPP data reflects how delaying needed property maintenance can result in higher costs as facility conditions continue to decline. For example, restoring a building from “average” condition to “excellent” condition costs \$58 per square foot, while the cost \$208 per square foot to restore a building from “crisis” condition to “excellent” condition.

There is perhaps no better example of the need to properly maintain state properties than the soon to be completed Minnesota State Capitol Restoration Project. The \$310 million project represents the single largest asset preservation project in state history that did not get underway until well after exterior marble deterioration and damage due to water intrusion began causing safety hazards. Regular, predictable investment is critical to ensure that buildings are adequately maintained and state property is cared for to maximize the investment that has already been made in state owned facilities.

Below is a summary of Admin’s asset preservation appropriations.

## **Funding summary**

The Department of Administration has received the following asset preservation funding for the preservation of Capitol Complex buildings and infrastructure:

- \$2.5 million in Fiscal Year 2005 (FY05)
- \$5 million in FY06
- \$0.00 in FY08
- \$8.075 million in FY10
- \$8.15 million in FY11
- \$0.500 million in FY12
- \$0.00 in FY14

The Department of Administration also receives and manages asset preservation appropriations on behalf of other state agencies that operate state facilities and create the funding requests. The following table contains a summary of asset preservation funds appropriated in 2011, 2012, and 2014 that have been expended on projects during calendar year 2016. The attached Tables 1, 2 and 3 list the specific projects that received funding (those amounts differ from the table below because the full funding amounts have not yet been expended).

## **Priority Projects for which Asset Preservation Funding will be sought**

All Agencies submitted their final 2016 asset preservation funding requests to Minnesota Management and Budget and the Governor submitted bonding recommendations to the legislature on the first day of the 2016 legislative session. No capital investment legislation or asset preservation funding was enacted in 2016.

Subsequently, the Governor again submitting bonding recommendations, including requests for asset preservation funding, to the legislature on the first day of the 2017 legislative session.
